#### Merit Review Application Materials

#### Local Deadline Dates

- **HSRD: Letter of Intent Deadline (HSRD) Career Development Awards (CDAs)** **Monday, April 3, 2017**  
VACO deadline is April 15.
- **HSRD: Intent to Submit Deadline (HSR&D) MERIT AWARDS** **Monday, April 17, 2017**  
VACO deadline is May 1. Intent to Submit must be submitted by the Investigator using a VA computer.
- **HSRD: Waiver for Off-site Research or exceeding duration/budget caps/IPAs** **Monday, May 1, 2017**  
VACO deadline is May 15.
  
- **RRD: Letter of Intent Deadline (RR&D) MERIT AWARDS and CDAs** **Monday, April 17, 2017**  
VACO deadline is May 1.
- **RRD: Waiver for Full Off-site Research or exceeding duration/budget caps** **Monday, April 17, 2017**  
VACO deadline is May 1.
  
- **Research Plan (14 page research plan + 4 pages of references)** **Monday, April 17, 2017**  
All **new** proposals **must** be reviewed and approved by the Scientific Review Subcommittee before submission to Central Office for funding consideration. **\*\* Please note: The R&D Committee will give concurrence for submission to Central Office only if the SRC has reviewed and approved the science of the project.\*\***
  
- **Scientific Subcommittee Review** **Monday, May 1, 2017**  
All **new** proposals **must** be reviewed and approved by the Scientific Review Subcommittee before submission to Central Office for funding consideration. This process is encouraged for all resubmissions. Following the Scientific Review Committee meeting you will receive required changes/recommendations to be incorporated into the final application.
  
- **Budget** **Monday, May 8, 2017**  
Prepare "drafts" of budget forms so you can review the budget with Mr. Gonzalez  
Make an appointment through the Research Office at (305) 575-3179
  
- **FINAL application package - COMPLETE** **Monday, May 29, 2017**  
Final application must be presented to Dr. Tran and Mr. Gonzalez for **final administrative review**. (You must use the forms discussed in new guidelines "VA Application Guideline SF424 (R&R)" available at <http://vawww.research.va.gov/funding/electronic-submission.cfm>)
  
- **Last possible submission date (to grants.gov)** **Monday, June 12, 2017**  
The electronic submission is held two business days in eRA Commons before being released to Central Office on June 15 (the due date).
